Project Overview

Low Carbon Dorset is a five year programme of activities to help stimulate growth in Dorset's low carbon economy. We offer FREE technical support and grant funding for innovative energy efficiency and renewable energy projects.

Funded by the European Regional Development Fund (ERDF), Low Carbon Dorset aims to help Dorset businesses reduce energy consumption, and improve competitiveness and profitability. The programme is run by Dorset Council and the Dorset Area of Outstanding Natural Beauty (AONB).

Our Objectives... (by Dec 2022)

- Support over 220 businesses to reduce their carbon footprint and associated costs through energy efficiency and renewable energy measures
- Support standard energy efficiency measures & more ambitious low carbon projects by businesses
- Support the introduction and future use of new and emerging technologies and solutions
- Support the development of new and innovative low carbon products and processes

Our Aims...

- ACCELERATE the deployment of energy efficiency and renewable energy technologies and approaches to reduce carbon emissions
- STIMULATE AND DEMONSTRATE innovation
- **SUPPORT** different types of low carbon projects and approaches within the Community, Public and Business Sectors
- **ENCOURAGE** biomass technologies as a key renewable energy technology for Dorset with wider benefits and potential for economic growth

Low Carbon Dorset is offering the following to Small & Medium Sized Enterprises (SMEs) in Dorset, Bournemouth & Poole:

FREE DIAGNOSTICS & TECHNICAL SUPPORT

Up to two days on site to explore your low carbon project ideas and opportunities. Followed by on-going support to get your project off the ground.

LOW CARBON GRANTS

To support the implementation of your project.

FREE BUSINESS SECTOR WORKSHOPS & NETWORKING EVENTS Designed specifically to meet the needs of business sector organisations

FREE DETAILED ENERGY SURVEY

More on Grants...

For individual projects, you can receive a grant for up to 40% of the total eligible project costs from the Low Carbon Dorset fund.

Typically, grants will be available:

- Up to £7,500 for standard energy efficiency measures
- Up to £250,000 for larger more complex low carbon projects
- Up to £40k towards the development of new low carbon product or practice

Who We Support

To receive support from Low Carbon Dorset, your organisation must be located within Dorset (including Bournemouth and Poole) and must be:



A legally constituted Small and Medium Sized Enterprise (SME) or new start-ups that are located and operate within the County of Dorset (including Bournemouth and Poole).

Your organisation is classified as a Small or Medium Sized Enterprise (SME) if:



You are an enterprise

AND



Your staff headcount (full time equivalent) is less than 250

AND



Either your annual turnover is less than 50 million Euros or your balance sheet is less than 43 million Euros

These ceilings apply to the figures for individual firms only. A firm that is part of larger group may need to include staff headcount/turnover/balance sheet data from that group too.

Types of Project

Low carbon technologies can offer your business a great opportunity to reduce energy consumption, and improve competitiveness and profitability.

What types of projects can we support?

STANDARD ENERGY EFFICIENCY MEASURES

E.g. insulation measures, boilers, lighting upgrades, motor and drives, voltage optimisation, double glazing, variable speed drives, compressed air systems

SMALL SCALE RENEWABLE ENERGY INSTALLATIONS (UP TO 5MW)

E.g. Biomass boilers, Renewable Heat (ground, air and water source heat pumps), On-shore wind, Marine energy, Solar PV, Small Scale Hydro.

USE OF INNOVATIVE OR NEW TECHNOLOGIES & APPROACHES

That reduce energy consumption in your business.

DEVELOPMENT OF NEW PRODUCTS OR PROCESSES WHICH HELP REDUCE CARBON EMISSIONS

E.g. proving concepts, research, marketing
